TRACOLA PRESCELTA

Delegations of EUMA and UIAA Executive Boards met on February 14 in Brussels to discuss the relationship and future collaboration between the two organizations. The entire meeting was held in a friendly and supportive atmosphere. Both - the EUMA as well as the UIAA delegation - emphasized having a strong interest in an efficient and close collaboration. Therefore, EUMA's and UIAA's strategic priorities as well as execution shall be synergetic at best to use member federations' funds as smart and efficient as possible.

Competing against each other would not be a suitable option, because both sides' main ambition is to promote and defend the legitimate interests of the climbers and mountaineers resp. of their national federations. There was also consensus in the ambition of supporting each other and sharing resources and projects to avoid "re-inventing the wheel twice".

EUMA emphasizes that based on their "Articles of Associations (§2)" the main areas of activity will be

huts, trails (also via ferratas) and winter-trails and climbing areas with regard to environmental protection, free access and safety aspects.

EUMA does not deal with the forms of organized competitive sports, developed from the mountain sports and will not interfere in these fields. UIAA respects the position and role of EUMA in Europe as well as EUMA respects UIAA's positioning as the worldwide authority & network for the climbing and mountain sports. Particularly the global UIAA competence in the field of safety of climbing and mountaineering hardware (safety label) was not contested by EUMA. Both sides agreed on establishing common strategic principles as well as a clear structure and processes guiding a systematic collaboration.

In order to substantiate their relationship, the UIAA and EUMA delegations agreed on the following next steps:

- Both sides define 2 contact persons (1 on board level at least)
- EUMA and UIAA will elaborate a joint document defining the content and working methods of their relationship. This paper shall be ready for approval by the General Assemblies of both organizations in 2018.
